

ORDINANCE 27-2023

**ORDINANCE OF THE CITY OF HERRIN, ILLINOIS TO ESTABLISH A HOME RULE MUNICIPAL RETAILERS OCCUPATION TAX AND HOME RULE MUNICIPAL SERVICE OCCUPATION TAX**

**Section 1. Tax Imposed.** A tax is hereby imposed upon all person engaged in the business of selling tangible personal property, other than an item of tangible personal property titled or registered with an agency of this State's government, at retail in this municipality at a rate of one-half (1/2) of one percent (1%) of the gross receipts from such sales made in the course of such business while this ordinance is in effect; and a tax is hereby imposed upon all persons engaged in this municipality in the business of making sales of service at the rate of one-half (1/2) of one percent (1%) of the selling price of all tangible personal property transferred by such serviceman as an incident to a sale of service. This "Home Rule Municipal Retailers' Occupation Tax" and this "Home Rule Municipal Service Occupation Tax" shall no be applicable to the sales of food for human consumption which is to be consumed off the premises where it is sold (other than alcoholic beverages, soft drinks and food that has been prepared for immediate consumption) and prescription and non-prescription medicines, drugs, medical appliances and insulin, urine testing materials, syringes and needles used by diabetics.

**Section 2.** This one-half (1/2) of one percent (1%) tax is in addition to the one and one-half percent (1 1/2 %) tax previously imposed.


**Section 3. Illinois Department of Revenue to Administer.** The taxes hereby imposed and all civil penalties that may be assessed as an incident thereto, shall be collected and enforced by the Department of Revenue of the State of Illinois. The Department of Revenue shall have full power to administer and enforce the provisions of this Ordinance.

**Section 4. Clerk to File Ordinance with Illinois Department of Revenue.** The Municipal Clerk is hereby directed to file a certified copy of this Ordinance with the Illinois Department of Revenue on or before October 1, 2023.

**Section 5. Effective Date.** This Ordinance shall take effect on the first day of January of the next year following the adoption and filing of this Ordinance with the Department of Revenue, if filed on or before the preceding October 1<sup>st</sup>.

**Section 6. Repeal of Conflicting Provisions.** All ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of the conflict, expressly repealed on the effective date of this Ordinance.
