Ordinance 9-2026

AN ORDINANCE AMENDING CHAPTER 38(WATER RATES) OF THE HERRIN REVISED CODE OF ORDINANCES

WHEREAS, it is necessary for the City to increase water rates to continue efficient operation of the Water Department; and

WHEREAS, the City Council of the City of Herrin has determined that it is in the best interest of the City to increase water rates.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF HERRIN, ILLINOIS AS FOLLOWS:

Section 1. Section 38-3-79 (A), (B) & (C) of the revised code is hereby amended by deleting the current language and inserting in lieu thereof, the following:

38-3-79 WATER RATES. There shall be and there are hereby established rates and charges for the use of and for the water supplied and furnished by the water works system of the City, based on the amount of water consumed, as shown by water meters, as follows:

(A) Inside City Rate Effective September 2026 Billing Cycle:

First	2,000 gallons or less	\$24.51 Minimum Charge
Next	2,000 gallons	\$ 8.53 per 1,000 gallons
Next	4,000 gallons	\$ 8.16 per 1,000 gallons
Next	92,000 gallons	\$ 7.71 per 1,000 gallons
Next	300,000 gallons	\$ 6.50 per 1,000 gallons
Next	600,000 gallons	\$ 5.11 per 1,000 gallons
Next	1,000,000 gallons	\$ 5.03 per 1,000 gallons

(B) Outside City Rate Effective September 2026 Billing Cycle:

First	2,000 gallons or less	\$38.03 Minimum Charge
Next	2,000 gallons	\$12.53 per 1,000 gallons
Next	4,000 gallons	\$11.98 per 1,000 gallons
Next	92,000 gallons	\$11.31 per 1,000 gallons
Next	300,000 gallons	\$ 9.51 per 1,000 gallons
Next	600,000 gallons	\$ 7.44 per 1,000 gallons
Next	1,000,000 gallons	\$ 7.34 Per 1,000 gallons

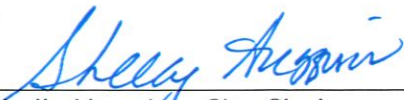
- (C) Municipalities and Villages. Water supplied and furnished to other municipalities and villages which make distribution through the distribution systems of said municipalities and villages shall be supplied at a rate of Four Dollars Eight-Six Cents (\$4.86) per one thousand (1,000) gallons effective with the September 2026 billing cycle.

All other sections in the Article shall remain unchanged.

Section 2. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 3. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.

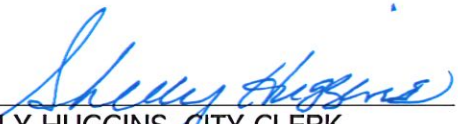
