Ordinance 14-2023

AN ORDINANCE ADDING CHAPTER 38(FIRE CONNECTIONS) TO THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF HERRIN, ILLINOIS AS FOLLOWS:

Section 1. Add the following section to the revised code:

38-3-80 FIRE CONNECTIONS.

- (A) Service connection for water to be taken for the extinguishment of fire shall be made only upon terms approved by the Public Works Superintendent. These terms shall include pipe size, rates and any other information needed for mutual agreement.
- (B) The following fee shall be collected each month for unmetered fire connections to the public water supply of Herrin:
 - 1. Automatic sprinkler systems shall be \$25.00 per connection.
- (C) A separate line (tap) shall be established for fire line and potable water. Calculations shall be submitted to determine property line sizing prior to construction.

Section 2. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 3. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
