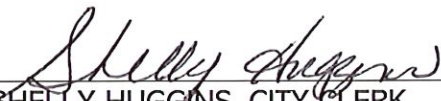

ORDINANCE 6-2026

AN ORDINANCE AMENDING CHAPTER 24, ARTICLE IX, SECTION 5
OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN,
ILLINOIS, AS FOLLOWS:

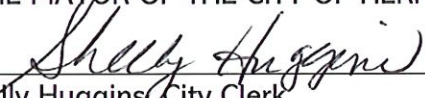
Section 1. 24-9-5 VIOLATIONS. That the current language be removed and the following be
inserted in lieu of:

24-9-5 VIOLATIONS. Any person who violates any provision of this Article shall be guilty of a
petty misdemeanor and shall be punished by a fine of **Two Hundred and Fifty Dollars**
(\$250.00).

Section 2. This ordinance shall become effective upon its passage, approval and publication in
accord with law.

Section 3. This ordinance is passed pursuant to the home rule authority of the City of Herrin,
Illinois.

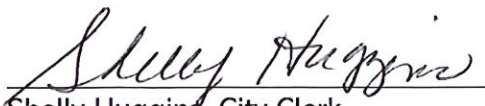

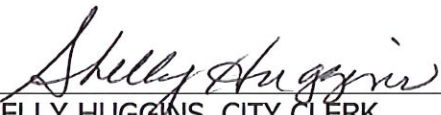
