Ordinance 13-2023

AN ORDINANCE AMENDING CHAPTER 38(SEWER RATES) OF THE HERRIN REVISED CODE OF ORDINANCES

WHEREAS, it is necessary for the City to increase sewer rates to continue efficient operation of the Sewer Department; and

WHEREAS, the City Council of the City of Herrin has determined that it is in the best interest of the City to increase sewer rates.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF HERRIN, ILLINOIS AS FOLLOWS:

Section 1. Section 38-4-73 of the revised code is hereby amended by deleting the current language and inserting in lieu thereof, the following:

38-4-73 DEBT SERVICE CHARGE. A debt service charge of Seven Dollars Fifty-Seven Cents (\$7.57) per user per month, to each user of wastewater facility of the City is hereby established. A capital improvement charge will be levied on all users as a fixed charge of One Dollar Twenty Cents (\$1.20) per month to provide funds for extension, improvements or reconstruction of the sewage treatment works.

Section 2. Section 38-4-74 of the revised code is hereby amended by deleting the current language and inserting in lieu thereof, the following:

38-4-74 BASIC SEWER RATE. There shall be and there is hereby established a minimum charge and a basic user rate for the use of and for service supplied by the Wastewater Facilities of the City. A minimum charge of Seventeen Dollars Twenty-Seven Cents (\$17.27) per month shall be applied to all users who are located inside the corporate limits of the City whose water consumption does not exceed two thousand (2,000) gallons per month and a minimum charge of Eighteen Dollars Fifty-Two Cents (\$18.52) per month shall be applied to all users who are located outside the corporate limits of the City whose consumption does not exceed two thousand (2,000) gallons per month. A basic user rate of Three Dollars Eight Five Cents (\$3.85) per one thousand (1,000) gallons shall be applied to all users for water consumption in excess of two thousand (2,000) gallons per month. The aforementioned minimum charges shall be effective starting the May 2023 billing cycle.

All non-metered residential users of the wastewater facilities shall pay a minimum flat rate charge per month adequate to cover the costs of the minimum accrual capital cost charge, the minimum service charge and the basic user rate of Seventeen Dollars Ninety-Seven Cents (\$17.97) per month for users located inside the corporate limits of the City and Twenty Dollars Seventy-Seven Cents (\$20.77) per month for users located outside the corporate limits of the City; these minimum flat rate charges shall be effective starting the May 2023 billing cycle. The flat rate charge will allow a maximum usage of five thousand (5,000) gallons per month. In the event use of the wastewater facilities is determined by the Superintendent to be in excess of **five thousand (5,000) gallons** per month, the Superintendent may require such flat rate user to install metering devices on the water supply to measure the amount of service supplied.

Section 3. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 4. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
