

ORDINANCE 9-2022

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE II, SECTION 1, SUBSECTION (I) OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS AS FOLLOWS:

Section 1. That the following section be amended:

15-2-1 Compensation for Department Directors & Employees

(I) Deputy City Clerk

Remove: The Deputy City Clerk shall receive **Three Hundred Dollars (\$300.00)** per year in clothing allowance.

Replace with: The Deputy City Clerk shall receive **Six Hundred Dollars (\$600.00)** per year in clothing allowance effective May 1, 2022.

ALL OTHER INFORMATION IN THIS SUBSECTION IS TO REMAIN UNCHANGED AT THIS TIME.

Section 2. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 3. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
