ORDINANCE 21-2022

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE II, SECTION 1, SUBSECTION (J) & (L) OF THE
HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS AS
FOLLOWS:

Section 1. 15-2-1 Compensation for Department Directors & Employees

(J) Animal Control Warden I

Remove:

Annual Salary: \$31,200.00

Replace with:

Hourly Rate: \$15/hour. Employee must work a 40-hour work week. Time worked over 40 hours per week will be paid at a rate of one and a half (1 ½) times the normal rate.

(L) Animal Control Warden II

Remove:

Annual Salary: \$24,960.00(\$12/hr)

Replace with:

Hourly Rate: \$14.41/hour. Employee must work a 40-hour work week. Time worked over 40 hours per week will be paid at a rate of one and a half (1 ½) times the normal rate.

***ALL OTHER INFORMATION IN THESE SUBSECTIONS IS TO REMAIN UNCHANGED AT THIS TIME.**

Section 2. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 3. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
