ORDINANCE NO. 2-2023

AN ORDINANCE AMENDING CHAPTER 1, ARTICLE III, SECTION 46, SUBSECTION (F) OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS, AS FOLLOWS:

**Section 1.** Chapter 1, Article III, Section 46, Subsection (F) regarding designated places of deposit is hereby removed and deleted and inserted in lieu of the following language:

**1-3-46 DEPOSIT OF FUNDS**


(F) The following bank(s) are herewith designated as places of deposit where the Treasurer of the City is required to keep all funds and monies in his custody belonging to this municipality:

- (1) Bank of Herrin, Herrin, IL
- (2) First Southern Bank, Herrin, IL
- (3) Southern Illinois Bank, Herrin, IL
- (4) People's National Bank, Herrin, IL
- (5) Banterra Bank, Herrin, IL
- (6) Farmer's State Bank, Herrin, IL

**Section 2.** This Ordinance is adopted pursuant to the home rule authority of the City of Herrin, Illinois.

**Section 3.** This Ordinance shall be effective after its passage, approval and publication in accordance with law.

Passed by the City Council of the City of Herrin, Illinois this 23<sup>rd</sup> day of JANUARY, 2023.




