ORDINANCE NO. 25-2022

AN ORDINANCE AMENDING CHAPTER 38, ARTICLE III, SECTION 78 OF THE HERRIN REVISED CODE OF ORDINANCES TO REGULATE WATER SERVICE CONNECTION FEES

Whereas, the City of Herrin, Illinois has the authority to regulate water service connection fees; and

Whereas, the City Council of the City of Herrin has determined that it is in the best interests of the City to impose certain increases on water service connection fees.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS, AS FOLLOWS:

Section 1. Chapter 38, Article III, Section 78 "Water Service Connections" is hereby removed and deleted and inserted in lieu of the following language:

38-3-78 WATER SERVICE CONNECTIONS. The water service tap connection fee shall be as follows:

| | INSIDE CITY | OUTSIDE CITY |
|-----------------------|-------------|--------------|
| 3/4" Water Connection | \$1,000.00 | \$1,800.00 |
| 1" Water Connection | \$1,400.00 | \$2,400.00 |

The City will run fifty (50) feet of water pipe and all pipe exceeding fifty (50) feet shall be billed to the applicant. Customer shall be responsible for the cost to directional bore service piping as permitted under existing highways and paved areas.

If a water connection is over one (1) inch in size, the applicant shall pay for the time and materials used in the installation, plus ten percent (10%) prior to the installation of the meter and connection. The cost of maintenance of all meters in excess of one (1) inch shall be the responsibility of the user; up to and including replacement.

All connections outside the corporate limits of the City shall be approved by the City Council.

Section 2. This Ordinance is adopted pursuant to the home rule authority of the City of Herrin, Illinois.

Section 3. This Ordinance shall be effective after its passage, approval and publication in accordance with law.
