

ORDINANCE 4-2026

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE II, SECTION 1,
SUBSECTIONS A, B, C, D, E & I OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN,
ILLINOIS, AS FOLLOWS:

Section 1. That Section 15-2-1(A) is hereby amended by changing the following:

15-2-1 (A) BUDGET DIRECTOR/HUMAN RESOURCES DIRECTOR

Annual Salary: \$92,586.11(Effective June 1, 2026)

All other items under this section remains unchanged.

Section 2. That Section 15-2-1(B) is hereby amended by changing the following:

15-2-1 (B) PUBLIC WORKS DIRECTOR

Annual Salary: \$128,543.70 (Effective June 1, 2026)

All other items under this section remains unchanged.

Section 3. That Section 15-2-1(C) is hereby amended by changing the following:

15-2-1(C) FIRE CHIEF

Annual Salary: \$122,034.55 (Effective June 1, 2026)

All other items under this section remains unchanged.

Section 4. That Section 15-2-1(D) is hereby amended by changing the following:

15-2-1(D) POLICE CHIEF

Annual Salary: \$119,572.32 (Effective June 1, 2026)

All other items under this section remains unchanged.

Section 5. That Section 15-2-1(E) is hereby amended by changing the following:

15-2-1(E) DEPUTY POLICE CHIEF

Annual Salary: \$102,834.48 (Effective June 1, 2026)

All other items under this section remains unchanged.

Section 6. That Section 15-2-1(I) is hereby amended by changing the following:

15-2-1(I) DEPUTY CITY CLERK

Annual Salary: \$42,000 (Effective June 1, 2026)


The Deputy City Clerk will have a clothing allowance of One Thousand Dollars (\$1,000)

All other items under this section remains unchanged.

Section 7. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 8. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.


