

ORDINANCE 6-2025

**ORDINANCE AMENDING CHAPTER 15, ARTICLE II, SECTION 1,
SUBSECTIONS (J) & (L) OF THE HERRIN REVISED CODE OF ORDINANCES**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN,
ILLINOIS AS FOLLOWS:**

Section 1. That the following section be amended:

15-2-1 Compensation for Department Directors & Employees

(J) Animal Control Warden I

Hourly Rate: \$19.00/hour. Employee must work a 40-hour work week.
Time worked over 40 hours per week will be paid at a rate of one and one-half (1 ½) times the normal rate.

(L) Animal Control Warden II


Hourly Rate: \$18.00/hour effective May 1, 2025. Employee must work a 40-hour work week. Time worked over 40 hours per week will be paid at a rate of one and one-half (1 ½) times the normal rate.

Section 2. This ordinance shall become effective upon its passage, approval and publication in accord with law.


