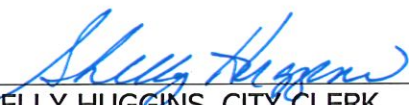

ORDINANCE 14-2026

**AN ORDINANCE AMENDING CHAPTER 24, SCHEDULE "D"
ONE WAY STREETS AND ALLEYS**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF HERRIN, ILLINOIS, AS FOLLOWS:**

Section 1. SCHEDULE "D". ONE-WAY STREETS AND ALLEYS. That is Chapter 24, Schedule "D" the following section be added thereto and inserting therein the following:

I. STREETS (PERMANENT).

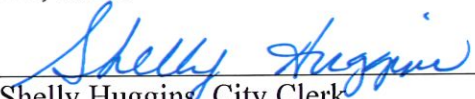
S. 14th St. (North Bound) between E. Ford St. & E. Ash St. from 7:30 a.m. until 3:30 p.m. Monday through Friday during the school year.

Section 2. This Ordinance is intended to and shall be in addition to all other Ordinances, rules and regulations concerning traffic, parking and use of street; and shall not be taken to repeal any other Ordinance or part of any other Ordinances unless in direct conflict therewith.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.

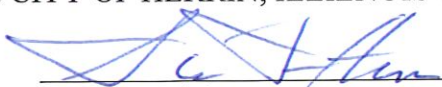
Section 4. This Ordinance is passed pursuant to the Home Rule Authority of the City of Herrin, Illinois.

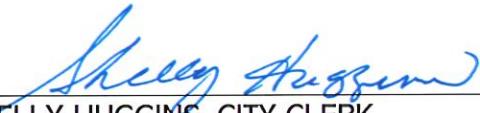
