## ORDINANCE NO. 3-2025

### AN ORDINANCE ADOPTING THE OFFICIAL ZONING DISTRICT MAP FOR THE CITY OF HERRIN, ILLINOIS

Whereas, the zoning district map for the City of Herrin, Illinois shows the various zoning districts as established in the Zoning ordinance; and

Whereas, the City engineer has updated and amended the Zoning District Map in accord with any changes occurring over the past twenty-four years; and

Whereas, it is necessary and appropriate for the City Council to adopt the Zoning District Map for the City of Herrin, Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS, AS FOLLOWS:

Section 1. The Zoning District Map, prepared by the City Engineer, dated October 2024(2025 Edition), is hereby approved and shall be the official Herrin Zoning District Map.

Section 2. All Ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 3. This Ordinance shall take effect from and after its passage and approval in accord with law.
