ORDINANCE 11-2023

AN ORDINANCE GRANTING A SPECIAL USE FOR 317 SMITH STREET

Whereas, the owner of property located at 317 Smith Street has requested to a special use for home occupation-woodworking; and

Whereas, the request for the rezone was considered by The Zoning Board of Appeals at a public hearing held on April 17, 2023, after notice of the time and place of the public hearing was published not more than thirty nor less than fifteen days before the hearing in the newspaper having general circulation within the City; and

Whereas, the Zoning Board of Appeals considered the request and voted to recommend to the Herrin City Council that the request for the special use be approved; and

Whereas, the Herrin City Council deems it in the best interest of the City of Herrin, Illinois to grant the special use.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS, AS FOLLOWS:

Section 1. The request for a special use for 317 Smith Street, Herrin, Illinois, is hereby granted.

Section 2. This ordinance shall become effective upon its passage, approval and publication in accord with law.

Section 3. This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
